## FARMERS' MARKET VENDOR REGISTRATION 2017

This year's *Red Bluff Chamber Saturday Farmers' Market* is scheduled to begin on Saturday, June 3rd, 7:30 AM - 12:00 p.m., at the **Red Bluff City River Park** and runs through September 30th.

The *Red Bluff Chamber's Wednesday Farmers' Market* will take place on Washington Street (in front of the **Tehama County Courthouse**) and a portion of Pine Street (between Jefferson & Main Streets), 5 - 8 p.m., beginning on June 7th through August 23.

Growers/Sellers must be Certified by the **Department of Agriculture**, 1760 Walnut Street, Red Bluff, (530) 527-4504. Some vendors may need to contact the **Department of Environmental Health**, 633 Washington Street, Room 36, Red Bluff, (530) 527-8020, or have a resale license from the **Board of Equalization**, 2881 Churn Creek, Suite B, Redding, (530) 224-4729.

To begin selling at either of the Markets, you must mail or deliver payment for Market Registration fee of **\$50** to the **Chamber** office. Registrations are due June 2nd, 2017. Late registration is **\$75** for all received after June 3rd. Applications must be turned in with a copy of your *Certified Producers Certificate*. Space numbers are being provided for the Wednesday evening market and Saturday market.

It is RECOMMENDED that you pre-register in our office, before the start of the market season. You must be registered before you are allowed to sell at either of our markets. Late Registration fee is **\$75**.

The daily stall rental fee is \$12 for each SATURDAY Markets and \$17 for each WEDNESDAY Market.
