1. Vehicles must be unloaded upon arrival and parked in designated areas as soon as unloaded. FREE all day parking is provided at designated areas. Set-up begins at 8 a.m. and must be completed by 9:00 a.m. All vehicles must be removed from vendor area before 9:00 a.m.
2. Dealers **must** remain set up throughout the entire day (9:00 a.m. - 2:00 p.m.). Take down begins at 2:00 p.m.
3. **10' X 12' Stall Rental: \$30 (\$50 if turned in after April 2nd!)**
4. Dealers are responsible for their own props, tables, chairs, and/or weather protection.
